Wangaratta Pickleball Club Inc acknowledges that risks are inherent in some aspects of Pickleball. Wangaratta Pickleball Club Inc also acknowledges that it faces a variety of other risks related to the pursuit and delivery of its strategy and day-to-day operations. For these reasons, Wangaratta Pickleball Club Inc understands the importance of a structured and systematised approach to the identification and management of risks.

Wangaratta Pickleball Club Inc is committed to managing and minimising risk by identifying, analysing, evaluating and treating risks to ensure Wangaratta Pickleball Club Inc has the best prospects for achieving its strategic objectives and maintaining effective and efficient operations for the benefit of its members, participants, followers and the broader community.

Wangaratta Pickleball Club Inc will regularly monitor, review and report on the effectiveness of its approach to risk management and aims to develop and maintain a risk aware culture. It will do this by adhering to the principles reflected in *ISO 31000:2018 Risk Management – Guidelines* as follows:

- Risk management activities are integral to Wangaratta Pickleball Club Inc and will be **integrated** across all Wangaratta Pickleball Club Inc areas and activities;
- Wangaratta Pickleball Club Inc will ensure a **structured and comprehensive** approach to risk management;
- Wangaratta Pickleball Club Inc's approach to risk management will be **customised** and appropriate for the nature and scale of our organization and the risks it faces;
- Wangaratta Pickleball Club Inc will be **inclusive** of relevant stakeholders to improve risk awareness and better inform its risk management efforts;

- Wangaratta Pickleball Club Inc will be **dynamic** in anticipating, detecting, acknowledging and responding to changing circumstances, events and the risk landscape;
- Wangaratta Pickleball Club Inc's risk management efforts shall utilise the **best available information** and inputs, spanning historical, current and predictive information from all relevant and available stakeholders;
- Wangaratta Pickleball Club Inc acknowledges that **human and cultural factors** influence all aspects of risk management and will promote a risk aware culture; and
- Wangaratta Pickleball Club Inc will strive for **continuous improvement** in its risk management performance.

Wangaratta Pickleball Club Inc directors, officers and executives recognise and acknowledge their responsibilities for effective risk management. These include providing leadership and direction, allocating appropriate resources, monitoring and responding to information as it becomes available and encouraging a culture where speaking up and raising concerns is encouraged.
